Water level in Mullaperiyar dam on Tuesday stood at 138.50 feet (permissible level is 142 ft.) with an inflow of 7,405 cusecs and a discharge of 1,867 cusecs. In Vaigai dam, the level was 69.09 ft. (maximum level 71 ft.) with an inflow of 12,955 cusecs and a discharge of 3,169 cusecs. Combined storage in Periyar credit was 9,502 mcft. HC reserves orders on pleas by freed convicts seeking release from camp

Centre says it has written to Sri Lankan authorities and is awaiting their response regarding their deportation; but petitioners say they do not want to return to the island nation

he Madurai Bench of the Madras High Court on Tuesday reserved orders on the petitions filed by two freed convicts of Rajiv Gandhi assassination case, S. Jeyakumar and B. Robert Payas, who sought their release from Foreigners Detention Centre in Tiruchi.

Justice G.R. Swaminathan reserved orders after hearing elaborate submissions made by the counsel for the petitioners, the Centre and the State.

During the hearing, the Centre submitted that the petitioners had no passport or visa and they were not Indian citizens. They had come to India from Sri Lanka. The Centre had

written to Sri Lankan authorities and was awaiting their response regarding the deportation of the petitioners.

It further submitted that if the Sri Lankan government accepted the petitioners as citizens, they would be deported to Sri Lanka, and if not, they would have to stay at the Tiruchi camp. However, if

they got visa from any other country, they could be deported to that country. The petitioners could not be let free from the camp, it was submitted. The petitioners said they wanted to live with their families. While Jeyakumar said he wanted to live with his family in Chennai, Robert Payas said he wanted to live with his family in The Netherlands. They, however, said they did not want to return to Sri Lanka.

They said sending them to the island nation was like sentencing them to death. They could get killed if they were sent to Sri Lanka. The authorities could not force any person to go to a particular country after the person said the move could claim his life, they said.

Ievakumar said he was suffering from sore eyes and losing eyesight. Since he was detained in the camp, he was not able to get proper treatment. Though he was taken to Chennai and Madurai for the treatment, he was not able to get continuous treatment and medication. Doctors had recommended a surgery, he said and sought his release from the camp so that he could stay with his family and get proper medical treatment.

Robert Payas said he had made representations to various organisations seeking their assistance to move to The Netherlands. Since he was detained at the special camp he did not get the opportunity to appear before the authorities concerned, he said.

Pregnant woman rescued from Thoothukudi admitted to GRH

A pregnant woman from Thoothukudi named P. Anushiya Mayil, 29, who was rescued along with her family members by a helicopter of the Indian Air Force on Tuesday, was admitted to the Government Rajaji Hospital here.

The woman along with her husband Perumal, her mother Sethulakshmi and one-and-a-half-year-old child was rescued from a building rooftop by the Indian Air Force personnel as they were stranded in a building surrounded by

Later in the day, they were brought to Madurai by air and taken to GRH for treatment. Ms. Sethulakshmi told the media that fearing that her daughter would deliver the baby at the house, they walked from their house towards the nearby government hospital, but got stuck en route due to heavy flow of water.

"We then took refuge in a relative's house. As to seek help, we wrote 'HELP' on a piece of paper with other details and showed it from the roof of a threestoried building to the rescue personnel on helicopter who came to drop relief items," she added.

Thankfully, they understood the seriousness and rescued us from the building with them, she said.

A senior doctor at GRH said that the pregnant woman was safe and added they were ready to receive patients from the flood-ridden areas. A total of 250 beds were ready to accommodate and a team of healthcare workers was ready to treat people, he added.

Relief materials collected from several districts were packed in Madurai and materials weighing about 8,780 kg were loaded in two Indian Air Force helicopters and were sent to flood-affected areas of Tirunelveli and Thoothukudi.

'Autorickshaw zones, akin to bus stops, will come up in city soon'

To regulate share autorickshaws and maintain the commuter's safety, autorickshaw zones would be set up in busy areas, said Traffic Deputy Commissioner of Police D. Kumar.

Speaking at an awareness meeting for share autorickshaw drivers, organised by the Madurai city police here on Tuesday, he said that mistakes committed by a few autorickshaw drivers would create a bad impression on all the drivers and in turn public would be hesitant to use autorickshaw.

Making note of the vaous violations on roads. Mr. Kumar pointed out that autorickshaw drivers had made a habit of stopping randomly on the road to board and deboard passengers which not only disturbs the traffic but also could lead to accidents.

Also, drivers should make use of the autorickshaw zones that would be set up soon in some of the important areas in the city to board and deboard passengers, he said.

A. Thirumalaikumar, Additional Deputy Commissioner of Police, Traffic,

while speaking at the meeting, warned that the installation of loud audio systems and illuminating lights in autorickshaws would not be entertained and if continued, they would be fined.

Further, he advised the drivers not to stick casterelated photos and words on the autorickshaws as it could provoke people. "Autorickshaws that are

privately owned should not be used for public purposes, as during times of accidents and other incidents, the damage would not be covered in insurance," he said.

Madurai central zone Road Transport Officer (RTO) Chitra listed out the fine amount that would be imposed for various violations on road.

"In most of the places, autorickshaws with altered seats to fit in more passengers could be seen, but drivers should realise that it was an offence," she added. "If caught with more passengers than the stipulated 3+1, the driver must pay a fine of ₹ 200 for each extra passenger," said Ms. Chitra. She instructed the autorickshaw drivers to carry their licence, insurance and other relevant documents, if not original at least the photocopy, along with them.

"As Madurai is a major tourist attraction in the State, many tourists from other States and countries would visit the place every day. Autorickshaw drivers who are the first to welcome and receive them should treat them with respect and dignity, as it would create a positive opinion about the people and the State," she added.

Normality will return to Thoothukudi within a week: CRA

Normality may return to the coastal district of Thoothukudi, which suffered unprecedented hammering by extremely heavy rainfall on Monday, within next one week, Commissioner for Revenue Administration S.K. Prabhakar has said.

Speaking to reporters here on Tuesday, Mr. Prabhakar said relief and rescue operations in the district, which had been battered by extremely heavy rainfall and consequent flood in the Tamirabharani river, had been expedited. Since there was no rain over the past 24 hours, the rescue teams could reach the hitherto inaccessible affected areas. These teams, including the Indian Army and Indian Air Force, had been rescuing people stranded in inundat-

Additional efforts were being made to feed and rescue the people stranded in mained isolated due to water stagnation. Besides the relief materials and food being sourced in Thoothukudi, assistance started arriving here from other districts. Additional manpower from other districts had been deployed across Thoothukudi to expedite restoration activities.

He said over 7,800 persons had been relocated to 27 relief camps in Tirunelveli Corporation area while another 26,000 were in 39 relief camps in rural Tirunelveli.
