(vi) Institutional set-up for liquidity risk management:

The Company has well defined policy to address the risk of mismatch between assets and liabilities either due to liquidity or changes in interest rate.

The Company periodically reviews the assets and liability positions, cost of funds, sources and mix of funding along with capital planning. The Company has conservative and prudent ALM policy that helps to provide adequate liquidity at all times. As on 30th June 2023, the Company has liquidity buffer of ₹396 crore. The Company strives to maintain a diversified source of borrowings viz. term loans, securitization, NCD etc. and short term borrowings through CC/OD. The strong ALM strategy is one of the key pillars of strength of the Company on a structural basis.
